



# Iowa Student Loan Nursing Education Loan Forgiveness Program Designation Form for Qualifying Loans Owned or Serviced by a Different Entity

***This is not an application for a loan.***

If you do not have any qualifying student loans owned Iowa Student Loan or serviced by Aspire Servicing Center<sup>SM</sup>, you may request your loan forgiveness benefits be applied to other qualifying student loans. This form is required only if you are requesting benefits for loans owned or serviced by an entity other than Iowa Student Loan or Aspire Servicing Center.

## Qualifying Student Loans Not Owned or Serviced by Iowa Student Loan

The following federal student loans qualify for loan forgiveness benefits under the Iowa Student Loan Nursing Education Loan Forgiveness Program:

- Federal Family Education Loan Program (FFELP) subsidized and unsubsidized Stafford Loans owned or serviced by an entity other than Iowa Student Loan or Aspire Servicing Center.
- William D. Ford Federal Direct Loan Program (Direct Loan) subsidized and unsubsidized Stafford Loans, including Direct Consolidation Loans, owned by the U.S. Department of Education and serviced by one its team of federal loan servicers.
- Other types of federal student loans that would be eligible for a Federal Consolidation Loan.
